Dear Chairman Kinskey, Chairman Nicholas, and members of the Joint Appropriations Committee,

The Wyoming Judicial Branch continues its very frugal spending tradition, with less than 4% of the General Fund allocated to it in the 2025-2026 biennium. We continue our critical role in maintaining law and order, to ensure the rights of litigants, the safety of our communities, and the stability of our businesses. Our judges and staff work every day to provide the just, speedy, and inexpensive resolution of Wyoming citizens' disputes. We are also mindful of the demands for resources you receive for many worthy purposes, and of your obligation to be fiscally responsible.

That is why our budget exception request is limited to two positions in our Branchwide Resource budget, both of which provide support across the Branch. Both positions were authorized by the 2022 legislature and funded through June 30, 2025. They have proven their function is necessary to the effective operation of the Branch, and we therefore request that you authorize permanent funding for 1) an Education Coordinator, to provide top-notch continuing education to our judges and clerks, enabling them to provide better service to litigants; and 2) a Records Specialist, to assist the circuit courts' responsiveness to constituent records requests, and to train clerks in archiving court records.

Thank you for your attention to this matter and for your service to the State of Wyoming.



#### INTRODUCTION TO THE WYOMING JUDICIAL BRANCH

The Judicial Branch serves a critical role in Wyoming's democratic process, and in maintaining law and order for our citizens. It ensures the constitutional rights of litigants, the safety of our communities, and the stability of our businesses. Our judges and staff work every day to provide the just, speedy, and inexpensive resolution of Wyoming's citizens' disputes. As envisioned by the founders over two hundred years ago, when the judicial system protects the rights of one, the rights of all remain secure.

The Wyoming Judicial Branch delivers this constitutionally guaranteed public service with only 352 employees, justices, judges, and retired judges in four distinct jurisdictional court conferences and one administrative office. The Supreme Court of Wyoming is a constitutional court and acts as the final arbiter of all issues involving Wyoming law. The 27 district courts are also constitutional and act as the general jurisdiction courts in Wyoming, meaning that these courts decide all cases not constitutionally or statutorily reserved to another court. The chancery court was created by the legislature in 2019 and is tasked with expeditiously resolving complex business, trust, and similar cases. The circuit courts of Wyoming, also a legislative creation, provide resolution of cases involving traffic offenses, misdemeanors, protection orders, evictions, and civil cases with up to \$50,000 in dispute. Wyoming courts handled more than 100,000 cases for Wyoming citizens in Fiscal Year 2024.

**BRANCHWIDE RESOURCES** 

The Branchwide Resources budget is reserved for costs that apply to the entire Judicial Branch or across multiple budget divisions within the Branch, including legal resource subscriptions, security, treatment court magistrates, education, and unfunded liability for annual leave and sick leave buy-outs for long-term employees who retire or terminate employment.

Included in this budget are three time-limited positions received during the 2022 Session and authorized through June 30, 2025. These positions are housed in the Administrative Office of the Courts, and the Judicial Branch is requesting permanent funding for two of those positions.

Standard Budget Request: \$ 6,642,374

### **EXCEPTION BUDGET REQUESTS**

#### Priority #1 – Positions

The time-limited positions received in 2022 have proven their value to the Branch. Of the three time-limited positions received, the Judicial Branch is requesting that two of these positions become permanent full-time positions.

1. <u>Education Coordinator</u> – The Judicial Branch Education Coordinator is responsible for the planning, coordination, and execution of educational programs and events for judicial officers and court staff. This position also manages the Judicial Branch's Learning Management System (LMS), ensuring efficient delivery of training content and tracking participant progress. The Education Coordinator works closely with various stakeholders to ensure all educational initiatives are effectively organized, support professional development, and comply with judicial training standards.

2. <u>Records Specialist</u> – The Judicial Branch Records Specialist is responsible for assisting in the management, preservation, and retrieval of official court records to assist the circuit courts' responsiveness to constituent records requests. This position works closely with court staff, state agencies, and the public to ensure timely access to court documents, adherence to legal requirements, and proper record retention policies. The Records Specialist ensures the systematic preservation of important documents allowing for easy retrieval when needed. Effective archiving and record management reduce the need for physical storage space and minimize the time spent searching for documents. This position has been invaluable in training circuit court staff on proper archiving of court records and assisting in bringing archiving up-todate in many of the courts.
