



**ORDER CREATING AND APPOINTING MEMBERS TO THE
BEHAVIORAL HEALTH COMMITTEE**

THIS MATTER came before the Wyoming Judicial Council, and the Wyoming Judicial Council deeming it necessary and proper to create a Behavioral Health Committee. It is therefore,

ORDERED that there be, and hereby is, a Behavioral Health Committee to review and recommend priorities of the Wyoming Judicial Branch in the area of behavioral health to the Wyoming Judicial Council. It is therefore,

ORDERED that the Behavioral Health Committee voting members shall consist of two Supreme Court Justices, two district court judges and two circuit court judges. Membership terms shall be three years and initial terms shall be staggered for each of the conferences to ensure continuity. Members may serve two consecutive terms; and it is further
