



**ORDER RESTRUCTURING THE BOARD OF COMMISSIONERS FOR EQUAL
JUSTICE WYOMING TO THE EQUAL JUSTICE WYOMING ADVISORY
COMMITTEE AND ORDER APPOINTING MEMBERS TO THE EQUAL
JUSTICE WYOMING ADVISORY COMMITTEE**

THIS MATTER came before the Wyoming Judicial Council, and the Wyoming Judicial Council deeming it necessary and proper to restructure the Board of Commissioners for Equal Justice Wyoming and to modify its purpose and structure, and to formally appoint members to the Equal Justice Wyoming Advisory Committee. It is therefore,

ORDERED that the Board of Commissioners for Equal Justice Wyoming shall be known as the Equal Justice Wyoming Advisory Committee. It is further,

ORDERED that there be, and hereby is, an Equal Justice Wyoming Advisory Committee to respond to requests from the Wyoming Judicial Council to promote and improve access to justice throughout Wyoming in accordance with the directives and intent of the Wyoming Civil Legal Services Act of 2010. It is further,

ORDERED that the Equal Justice Wyoming Advisory Committee voting members shall consist of no more than twelve volunteer members, and is recommended to include at least one, but not more than two district court judges and at least one, but not more than two circuit court judges. Membership terms shall be two years, and initial terms shall be staggered for each stakeholder group represented to ensure continuity. Members may serve consecutive terms. It is further,

ORDERED that the Equal Justice Wyoming Advisory Committee shall consist of the following members:
