**ORDER RESTRUCTURING AND APPOINTING MEMBERS TO THE
EFILING COMMITTEE**

THIS MATTER came before the Wyoming Judicial Council, and the Wyoming Judicial Council deeming it necessary and proper to restructure the ad hoc eFiling Committee. It is, therefore,

ORDERED that there be, and hereby is, an eFiling Committee to review and recommend eFiling and access improvements to the Wyoming Judicial Council to ensure a coordinated approach to eFiling and access in Wyoming's trial courts; it is further

ORDERED that the eFiling Committee voting members shall consist of one Supreme Court Justice, appointed by the Chief Justice of the Wyoming Supreme Court; two district court judges, appointed by the District Court Judges Conference; two circuit court judges, appointed by the Circuit Court Judges Conference; the chancery court judge; three to five practicing attorneys, appointed by the Wyoming State Bar; a prosecuting and county attorney, appointed by the Wyoming County and Prosecuting Attorney Association; two clerks of district court, appointed by the District Court Clerks Association; two district court judicial assistants, appointed by the District Court Judges Conference; one district court reporter appointed by the District Court Judges Conference; and two circuit court chief clerks, appointed by the Circuit Court Judges Conference. Membership terms shall be for two years with initial appointment terms staggered for each of the conferences to ensure continuity. Members may serve consecutive terms. The Chief Justice or a designee shall chair the committee; it is further

ORDERED that Hon. Robert C. Jarosh will serve as chairperson; and it is further

ORDERED that the eFiling Committee shall consist of the following members:
