MOTION AND AFFIDAVIT TO ALLOW ALTERNATIVE SERVICE

1. I am the Plaintiff/Petitioner in this case. Under penalty of perjury, I state that I believe the following to be true and correct:

2. Service of a Summons cannot be made on the Defendant/Respondent in Wyoming.

3. Wyoming Rule of Civil Procedure 4(k)(9) allows alternative service in this case. This is the Motion and Affidavit required by Rule 4(l)(1).

6. ☐ By filing this Motion and Affidavit, I am asking the Clerk of District Court to serve the Complaint or Petition, along with the Summons, to the Defendant/Respondent at the

address listed above using certified or registered mail. This will be done instead of service by any other alternative method. This is allowed by Wyoming Rule of Civil Procedure 4(r)(2). I understand that I cannot ask for this kind of service unless I provided the Defendant/Respondent's current address above.

- ☐ By filing this Motion and Affidavit, I am telling the Court that I do not know of any method of alternative service that I could use to give the Defendant/Respondent actual notice of the documents that I need to serve. I do not have reliable, consistent interactions with the Defendant/Respondent through email, text messaging, social media platforms, or other communication applications. Because I don't have other ways to give the documents to the Defendant/Respondent, I am asking the Court to allow me to complete service by publication.
